



The League of Women Voters of Florida is pleased to send you an application to register to vote. Please take your time and fill it out according to the directions on the form and the simple guidelines in this letter.

Just above Question 1, mark whether this is a new registration or not. A new registration means that this is the first time you are registering to vote in Florida.

Question 1. Mark whether you are a U.S. citizen or not.

Question 2. Mark that you are not a felon or if you are, that your rights have been restored. EXPLANATION: If you have a felony conviction (except for murder or felony sex offenses) * and you finished incarceration, probation, and parole and paid all of the financial obligations of your sentence, then you can register to vote because your rights were restored by Amendment 4.

Question 3. If a judge has NOT determined that you are mentally unable to take care of yourself then mark the box in question 3.

Question 4. Date of birth. MM-DD- Year.

Question 5. Fill in your Florida driver's license or other State of Florida ID card. Or you can provide the last four numbers of your social security number.

Question 6. Your name. Last in first box, then your first name.

Question 7. Address where you live.

Question 8. Mailing address if it is different than address where you live.

Question 9. Address where you last registered to vote, if you registered to vote before.

* (If you have a conviction for murder or a felony sex offense then your rights **are not** restored by Amendment 4. You would need to apply to the governor for clemency)

Question 10. Mark your gender.

Question 11. Indicate whether you want a sample ballot emailed to you. If yes, write in your email address.

Party Affiliation is very important but it is not required. When you pick a party you will be able to vote in that party's primary to select the party's candidate. Your race is also requested, if you wish to provide that information.

If you are active duty military or a spouse of active duty military, indicate that. If you are a US citizen residing outside of the USA, then indicate that.

Question 12. Sign the Application in the red box. Take your time. This is going to be the signature on file that they will compare with your other signatures if you vote by mail. We recommend that you take a photo of your signature.

Review all of your answers for correctness and completeness.

Then mail your completed and signed Voter Registration form to your local Supervisor of Elections or drop it off at the Supervisor's address.

If you have any questions about registering to vote, or you are unsure about your sentence, or whether you have any outstanding financial obligations of your sentence remaining, you may check the county courthouse where you were convicted of a felony, to check your records, or you may ask the League to refer you to a pro bono lawyer trained to assist people to research their records or file court papers so you are able to vote.
